If any Muslim Festival mentioned in the list of Govt. holidays vide Finance Department Notification No. 4188-F (P2) dated 27.11.2025, will be subsequently deferred/alterd; Hon'ble Benches and office of the Tribunal will observe the holidays so deferred/alterd on the day which shall be finally declared by the Govt. on account of the Muslim Festivals.

* Holidays on account of Muslim Festivals viz. Eid-Ul-Fitr, Eid-Uz-Zoha (Bakrid) and Muharram and Feteha-Duaz-Daham will be declared by the Hon'ble High Court later on, depending on visibility of the moon, as notified in Note: 3 of Notification No. 4897-G.S. dated 17.12.2025.
