
In partial modification of the Order No. 637- WBAT/2J-15/2016, dated 27/06/2018, the constitution of the Hon'ble Benches of the Tribunal would be as follows :-

The cases already fixed for the Hon'ble First Bench regarding i) Residual matters not covered by this determination and Applications arising out of cases/distribution or allotment of work (**Determination Code - 4**) will be taken up by **Justice Soumitra Pal, Hon'ble Chairman** and **Dr. Subesh Kumar Das, Hon'ble Member (A)** on every Monday and Tuesday in the first half only and Friday till 12-30 hrs. and ii) Recruitment, Appointment (**Determination Code - 1**) will be taken up by **Justice Soumitra Pal, Hon'ble Chairman** and **Shri P. Ramesh Kumar, Hon'ble Member (A)** on every Wednesday and Thursday in the first half only .

Besides, for convenience, instead of listing cases of Pension, Retiral Benefit, continuation of Past Services and allied matters/Death benefit (**Determination Code - 12**) before the Hon'ble 1<sup>st</sup> Bench only; all the Hon'ble Benches will have concurrent jurisdiction to take up such Cases.
