## NOTIFICATION

No. 17-WBAT/1E-08/2003(Pt.-I)

Date :10.01.2022.

In exercise of the powers conferred by sub-section (6) of section 5 of the Administrative Tribunals Act, 1985 and further taking into consideration of the solemn observations of the Hon'ble High Court, Calcutta in the case of Mithu Mondal and Others -versus- The State of West Bengal and Others reported in 2012 (4) Calcutta High Court Notes 320 and the Hon'ble Supreme Court of India in All India Institute of Medical Sciences -versus- Sanjeev Chaturvedi reported in All India Reporter 2019 Supreme Court 2971 (paragraph 72), I hereby authorize Shri Sayeed Ahmed Baba, Hon'ble Member (Administrative) of the West Bengal Administrative Tribunal to function as Bench No. 2 consisting of a Single Member and exercise the jurisdiction, powers and authority of the Tribunal as per schedule of Classification of cases published on 24.12.2020 and 08.01.2021 in respect of the matters listed in the daily cause list dated 11.01.2022 of the West Bengal Administrative Tribunal subject to the following procedure.

- (1) That the case does not involve validity of any statutory provision or interpretation of any of the provisions of the Constitution of India.
- (2) That it is open to either party to submit to the Single Member before the matter is taken up for admission or final hearing, that it may be placed before bench of two Members. If such a request is made at the outset, the Single Member shall direct that the case be placed before an appropriate Bench of two Members. Once the case is taken up, no such request shall be entertained at any subsequent stage of the proceedings for admission or final hearing as the case may be.
- (3) No contempt or review or recalling application will be disposed of on merit.

Explanation:

- (i) The party not making the request at the stage of admission shall not be precluded from making such a request when the case is taken up for final hearing.
- (ii) The stage of admission would also cover cases which may be finally disposed of with the consent of parties at the admission stage.
- (iii) Notwithstanding anything contained in the previous paragraphs if any, any stage of the proceedings, it appears to the Single Member that the case is of such a nature that it ought to be heard by a Bench of two members, he may refer it to the Chairman to transfer it to a Bench of two members.
