


- Matters including part heard, contempt application, review, modification relating to orders/judgment passed by the former 2nd Bench consisting of the Hon'ble Justice Ranjit Kumar Bag and Hon'ble Administrative Member Dr. Subesh Kumar Das shall be heard by the 1st Bench and 2nd Bench in Court Room No. 1 according to the classifications as stated above.
- The cases pertaining to erstwhile Bench No. 3 will be henceforth taken up by the Bench No. 2.
- The application for contempt, review, modification/clarification of order/judgment will be heard by the Bench consisting of Hon'ble Members who passed the order/delivered the judgment. If one of the Hon'ble Members demits his office after passing the order/judgment, the Registry will place the application or case before the Hon'ble Chairman for assignment. If both Hon'ble Members retire, the application will be heard by the Bench having determination for which violation/review/modification is prayed for.
- Part heard matter, CAV matter will be dealt with by the Hon'ble Members who heard the same, irrespective of whether or not the Hon'ble Members have determination at present to deal with the same. If one of the Hon'ble Members who heard the matter retires, the said matter will be taken up by the Bench consisting of the Hon'ble sitting Member who heard the matter along with the new Member who is now part of the said Bench. If both the Hon'ble Members retire without disposing of part heard matter and without delivery of judgment in CAV matter, the same will be placed before the Hon'ble Chairman for assignment.
- The Miscellaneous Application for restoration of the Original Application by recalling / setting aside order of "Dismissal for Default" will be heard by the Regular Bench which has the determination to take up the hearing of the Original Application.
- The new dates of application for contempt, review, modification/clarification of order/judgment will be assigned by the Hon'ble Judicial Members of the respective Benches, sitting in Single Benches on days/sessions apart from the scheduled regular Benches.
- The cases already fixed in accordance with the determination prior to this arrangement shall appear on the next available date as per the current determination of the Hon'ble Benches.
