#### ORDER

No:-118-WBAT/1E-08/2003(Pt.-II)

Date:-11.02.2022

In exercise of the powers conferred by sub-section (6) of section 5 of the Administrative Tribunals Act, 1985 and further taking into consideration of the solemn observations of the Hon'ble High Court, Calcutta in the case of Mithu Mondal and Others -versus- The State of West Bengal and Others reported in 2012 (4) Calcutta High Court Notes 320 and the Hon'ble Supreme Court of India in All India Institute of Medical Sciences -versus-Sanjeev Chaturvedi, reported in All India Reporter 2019 Supreme Court 2971 (paragraph 72) and further considering speedy disposal of the cases, I hereby authorize myself Soumitra Pal, Smt. Urmita Datta (Sen) and Shri Sayeed Ahmed Baba, Hon'ble Members (Judicial and Administrative) of the West Bengal Administrative Tribunal to function as Bench Nos.1, 2 and 3 respectively consisting of a Single Member and exercise the jurisdiction, power and authority of the Tribunal as per schedule of Classification of Cases and functioning of the Benches as published today i.e. on 11.02.2022 as per daily cause list of the West Bengal Administrative Tribunal subject to the following procedure.

- (1) That the case does not involve validity of any statutory provision or interpretation of any of the provisions of the Constitution of India.
- (2) That it is open to either party to submit to the Single Member before the matter is taken up for admission or final hearing, that it may be placed, before bench of two Members. If such a request is made at the outset, the Single Member shall direct that the case be placed before an appropriate Bench of two Members. Once the case is taken up, no such request shall be entertained at any subsequent stage of the proceedings for admission or final hearing as the case may be.
- (3) No contempt or review or recalling application in respect of an order passed by the Division Bench on or before 10.02.2022 will be disposed of on merit.

#### It is further ordered as follows:-

- The party not making the request at the first instance before the Single Bench shall not be precluded (i) from making such a request when the case is taken up for final hearing.
- The stage of first instance would also cover cases which may be finally disposed of with the consent (ii) of parties at the admission, and / or, initial stage.
- Notwithstanding anything contained in the previous paragraphs if any, any stage of the proceedings, it (iii) appears to the Single Member that the case is of such a nature that it ought to be heard by a Bench of two members, he/she may refer it to the Chairman to transfer it to a Bench of two members.
- Matters including part heard, contempt application, review, modification relating to orders / judgment previously passed by the Bench consisting of the Two Members shall be heard by the 1st Division Bench and 2nd Division Bench according to the classifications of the cases of the Division Bench published on 11.02.2022.
- The application for contempt, review, modification / clarification of order / judgment will be heard by the Bench consisting of Hon'ble Member or Members who passed the order / delivered the judgment. If one of the Hon'ble Members demits his office after passing the order / judgment, the Registry will place the application or case before the Hon'ble Chairman for assignment. If both Hon'ble Members demit, the application will be heard by the Bench having determination for which violation / review / modification is prayed for.

- (vi) Part heard matter, CAV matter will be dealt with by the Hon'ble Members who heard the same, irrespective of whether or not the Hon'ble Members have determination at present to deal with the same. If one of the Hon'ble Members who heard the matter demits, the said matter will be taken up by the Bench consisting of the Hon'ble sitting Members who heard the matter along with the new Member who is now part of the said Bench. If both the Hon'ble Members retire without disposing of part heard matter and without delivery of judgment in CAV matter, the same will be placed before the Hon'ble Chairman for assignment.
- (vii) The Miscellaneous Application for restoration of the Original Application by recalling / setting aside order of "Dismissal for Default" will be heard by the Regular Bench sitting singly which has the determination to take up the hearing of the Original Application.
- (viii) The Registrar will continue his functions in terms of Rule 28 of the West Bengal Administrative Tribunal (Procedure) Rules, 1994 and receive Reply, Rejoinder to place the cases before the Hon'ble Bench having jurisdictions.
- (ix) The Registrar is further directed to fix next date of the cases which are undated due to restricted functioning of the Tribunal during Covid-19 pandemic.
- (x) This order will remain in force until further order.
