(b) An order do issue directing the respondents particularly the respondent No.2 herein to issue onward formalities in accordance with law including issuance of appointment letter to the applicant, if the applicant passed in the written test for the post of "Cashier-cum-LDA" in the ICDS project forthwith."

It appears that the said written test was held on 22nd April, 2007. According to the applicant since the results were not published, an application under the Right to Information Act, 2005 was submitted on 21st December, 2011 before the respondent authorities as evident from page 12 of the application. Thereafter the applicant had filed another application on 1st October, 2018 under the 2005 Act which was replied to by the State Public Information Officer, Directorate of I.C.D.S., Kolkata on 7th December, 2018 stating inter alia that "Result of the said examination is not yet published."

It is submitted by Mr. M.N. Ray, learned advocate for the applicant that since every selection process comes to an end with the publication of the result, appropriate direction may be given to the respondents directing them to publish the result.
