appears that thereafter the office order dated 11<sup>th</sup> March, 2020 was cancelled by order dated 14<sup>th</sup> July 2020 and she was directed to report to the BMOH, Pathardih BPHC. According to the applicant these frequent transfers from one Sub-Centre to the other is arbitrary and illegal. Submission is since representation dated 17<sup>th</sup> July, 2020 has been filed before the respondent no.3, the said respondents may be directed to consider it and till it is considered, the transfer order may be stayed and order be issued directing that no penal action be taken.

Mr. S. Ghosh, learned advocate appearing on behalf of the State respondents submits that, if directed, the State respondents will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the Original Application is disposed of by granting liberty to the applicant to file a representation afresh before the Chief Medical Officer of Health, Purulia, the respondent no.3 by 25<sup>th</sup> September, 2020 along with a copy of this order downloaded from the internet / website and if such representation is filed within the time as stipulated, the said respondent no.3 shall dispose of the same by passing a reasoned order with regard to her posting which will be communicated to her within four weeks after giving an opportunity of hearing.
