	31^{st} October, 2011, has challenged the memo dated 30^{th}	
	December, 2012 being annexure 'D' to the application,

	amount of Rs.2,53,479/- on the ground of drawal of Pay	
	and House Rent Allowance by the applicant.

	It is submitted by Mr. S.N. Ray, learned advocate	
	for the applicant that the allegation of withdrawal of house	
	rent allowance of Rs.1,53,058/- is incorrect as though his	
	wife serving in Kendriya Vidyalaya Sangathan, Salt Lake	
	Kolkata drew house rent allowance, the entire drawal was	
	within the ceiling limit prescribed under law and was also	
	disclosed before the authorities. We find that that said	
	disclosure, if at all, is not on record before us. Mr. Ray	
	submits that if an opportunity is given, the applicant can	
	produce records showing full disclosure already made	
	before the authority concerned. In such view of the	
	matter, considering the facts and circumstances of the	
	case, this application is disposed of by granting liberty to	
	the applicant to file representation ventilating his entire
