Registration" Perusing the "Student's respondents. certificate issued by Nikhil Bangiya Vidyapeeth, Dalkhola - 733201, Uttar Dinajpur, appearing at page 24 of the application, we find it is incomplete as the session column has been left blank and the signature of the candidate is It is strange that on the strength of such missing. registration, the applicant got admission in the Vidyapeeth, as evident from the diploma in Medical Technology granted to the applicant by the said Institution appearing at page 28 of the application. Moreover, a bare perusal of the said diploma does not inspire confidence and cannot be relied on as it has been mentioned that the Vidyapeeth has been "Authorised :- U.G.C. & M.H.R.D. Govt Of India Recognised University". However, in the next line it has been mentioned, "Not in the purview of U.G.C. Govt. Of India", "Medical Council of India......" and "Pharmacy Council Of India Govt. the said registration certificate and diploma.

Moreover, as this application has been filed on 10^{th} April, 2019 after the last date of interview was over on 2nd April, 2019, directions cannot be issued for arranging an interview "as a special case". Hence, the application is dismissed.
