respondents immediately to consider the candidature of the applicant for recommendation in the West Bengal Legal Service on the basis of the Result of West Bengal Legal Service Examination 2014.

- (b) Direction be given to the respondents to recommended the candidature of the applicant to the State of West Bengal after considering the case of the petitioner.
- (c) To give appointment to the applicant after her name being recommended by the respondent no.1."

Referring to the advertisement being Annexure "A" to the application, it is submitted by Mr. Sanyal that the applicant belongs to the unreserved category. Out of 40 vacancies, 21 vacancies were under the unreserved category. After the applicant had participated in the examination, the applicant filed an application before the State Public Information Officer, Law Department, Government of West Bengal, Kolkata on 6th June, 2018 requesting for information under the Right to Information Act, 2005. The applicant was informed that the applicant stood 29th in the unreserved category as evident from page 27 of the Original Application. According to the applicant, as 9 candidates did not turn up during verification of documents, and as a result, the applicant

Mr. A.L. Basu, learned advocate for the Public Service Commission submits that out of 40 vacancies, 21 vacancies were earmarked for unreserved candidates. The applicant stood 29th. It is submitted that West Bengal Public Service Commission on 4th April, 2017 had recommended 21 names under the unreserved category. The name of the applicant cannot be recommended as under the Rules once the Public Service Commission recommends it cannot be amended or altered on the basis of prayer made by an applicant. Having heard the learned advocates for the parties, since we find the Public Service Commission has SCN. already recommended names of 21 candidates and there is no scope for further recommendation, particularly on the basis of representation made by the applicant, no order is passed on this application.
