	The applicant has prayed for giving direction upon the respondents to release the amount of Group Insurance under the scheme in favour of the applicant.	
	None appears on behalf of the State respondents inspite of service of notice as reflected from the affidavit of service filed on behalf of the applicants.	
	It appears from the materials on record that one Nirmal Chowdhury died on December 11, 2012 while he was working as Medical Officer of Sagar Dutta Medical College and Hospital. The contention of the applicants is that the applicant No. 1 being the mother of late Nirmal Chowdhury is the only legal heir, as Nirmal Chowdhury was divorcee. By issuing letter dated November 17, 2016, the respondent No. 3 asked the applicant No. 1 to produce Succession Certificate for receiving arrears of salary of Nirmal Chowdhury and for receiving amount of Group

	Learned Counsel representing the applicants submits that	
	the insurance part of Group Insurance Scheme envisaged	
	under West Bengal State Government Employees (Group	
	Insurance-cum-Savings) Scheme, 1987 has not yet been	
	released by the respondent No. 3.	
	On consideration of the Group Insurance-cum-	
	Savings Scheme, 1987, we find that the amount of	
	insurance money in case of death of the employee while in	
	service will be paid to the legal heirs in equal share on	
	furnishing of indemnity bond, if there is no nomination of	
	the concerned employee. In the present case, the deceased	
	employee, Nirmal Chowdhury used to deduct Rs. 80/-	
	(Rupees eighty only) per month from his monthly salary	
	for the purpose of group insurance-cum-savings and as	
	such, the legal heirs of Nirmal Chowdhury are entitled to	
	receive Rs. 80,000/- (Rupees eighty thousand only) as the	
	amount of Group Insurance under the scheme of 1987.	
	Since the applicant No. 1 is the only legal heir of the	
	deceased Nirmal Chowdhury and since the amount of Rs.	
	80,000/- (Rupees eighty thousand only) has not been	
	released after death of Nirmal Chowdhury in favour of the	
	applicant No. 1, we are of the view that the applicant No.	
	1 is entitled to get the said amount of Rs. 80,000/- (Rupees	
	eighty thousand only) on furnishing of indemnity bond, as	
	there is no nomination in the instant case by the deceased
