It appears that the applicant had filled up online application for appearing in the examination for pursuing Super Speciality Course in Clinical Haematology. Admit card was issued by the National Board of Examinations, NEET-SS 2019 for appearing in the examination for Super Speciality Course in Clinical Haematology scheduled to be held on 28<sup>th</sup> June, 2019. She participated in the examination and result was published wherein she scored 280 marks out of 400 and secured 57<sup>th</sup> rank. It appears that among the 56 candidates who have filled up the vacancies for the course, Deep Jyoti Kalita, ranked 20, has resigned the seat from Medical College, Kolkata. According to the applicant as the seat has fallen vacant and no steps have been taken for stray counselling, the applicant, being the first waiting list candidate, has sent e-mails to the Principal, Medical College, Kolkata, the respondent no.4 for pursuing the course. As no steps have been taken, aggrieved this application has been filed.

Mr. M.N. Roy, learned advocate for the applicant submits, as the seat has fallen vacant, under the law she is entitled to be admitted in the course.

Mr. G.P. Banerjee, learned advocate for the State respondent nos.1 to 5 submits that as the vacancy is declared by the ADG (ME), Medical Counselling Committee, New Delhi, the respondent no.6, steps could not be taken by the State authorities.
