applicant without causing delay, so as to enable him to undergo Clinical Fellowship in Hand Surgery at Tan Tack Seng Hospital, Singapore which will be held on and from 6<sup>th</sup> December, 2019."

Submission is though representation dated 23<sup>rd</sup> May, 2019 was filed before the Director of Medical Education and Ex-Officio Secretary, West Bengal Medical Education Services, Department of Health and Family Welfare, Government of West Bengal, Kolkata, the respondent no.2 praying for leave to undergo comprehensive training in hand surgery in Singapore and thereafter reminders were given on 17th June, 2019 and on 13th November, 2019 before the said respondent and though he has given an undertaking to rejoin in the Department of Plastic and Reconstructive Surgery, R.G.
