service on 31st March, 2016, - has prayed for a direction upon the respondents to release pension with effect from 1st April, 2016 by condoning the shortfall of service.

Mrs. S. Mitra, learned advocate for the applicant, - relying on the statements in the application and in the rejoinder and relying on the judgement of the High Court passed on 13th April, 2019 in W.P.S.T. 532 of 2010, Nemai Ch. Chatterjee & Others vs. State of West Bengal & Others, - has submitted that since the applicant was absorbed in the service after rendering continuous temporary uninterrupted continued service from early 2006 and as he has qualified for payment of pension, appropriate order may be passed.

Having heard Mrs. Mitra, and considering the facts and circumstances of the case, since we find the applicant absorbed in permanent service on 3rd October, 2008 had superannuated on 31st March, 2016, the application is disposed of by directing the Principal Chief Conservator of Forest (HOFF), West Bengal, the respondent no.2 to dispose of the matter regarding grant of pension to the applicant by passing a reasoned order to be communicated to the parties within twelve weeks from the date of presentation of a copy of the certified copy of this order after giving an opportunity for hearing to the applicant and after perusing the records whether the
