Submission is the applicant has been informed of not being selected for promotion as he was not found suitable as his ACRs were found to be average for the period 2009-10, 2010-11, 2011-12 and 2012-13. It is submitted that pursuant to an application under Right to Information Act, 2005 the applicant has been informed that for the period from 2009-2010, 2010-2011, 2011-2012 and 2012-2013 the ACRs were initiated by one Rabindranath Mondal, Joint Director, ARD, who according to the applicant was not competent to initiate the issue and accordingly the denial of promotion is uncalled for and illegal. Submission is since a representation dated 16<sup>th</sup> July, 2019 has been furnished before the Principal Secretary to the Government of West Bengal, Animal Resources Development Department, Kolkata, the respondent no.1, appropriate order may be passed for consideration of the same.

Having heard Mr. Ghosh and considering the facts and circumstances of the case, the application is disposed of by directing the Additional Chief Secretary, of Animal Department Resources Development, Government of West Bengal, Kolkata, the respondent no.1, to give a reply to the representation dated 16<sup>th</sup> July, 2019 appearing at page 13 of the Original Application within eight weeks from the date of
