Banerjee, Learned Advocate.</p> <p>The applicant was appointed in the post of Sub-Inspector in subordinate Food &amp; Supplies Service, Grade III on the basis of results of Recruitment Examination, 2014 conducted by West Bengal Staff Selection Commission on the basis of order dated April 11, 2017 issued by the Director, Directorate of DDP &amp; S, Department of Food &amp; Supplies, Government of West Bengal.</p> <p>The contention of the applicant is that on April 21, 2017, he went to the office of DDP&amp;S for joining on the basis of order dated April 11, 2017 issued by Director, Directorate of DDP&amp;S, but he was not allowed to join. The further contention of the applicant is that on May 4, 2017, he submitted one joining report before the Director of DDP&amp;S, but the said joining report was not accepted. Accordingly, the applicant has prayed for direction upon the respondents to permit the applicant to join in the post of Sub-Inspector in Food &amp; Supplies Department.</p> <p>Mr. Banerjee, Learned Counsel representing the state respondents, submits that on May 4, 2017, the applicant went to the office for joining but could not draft joining report in English. the applicant submitted one joining report in Bengali with several spelling mistakes and ultimately the applicant left the office without submitting the joining report.

Having heard Learned Counsel representing both parties and on consideration of the fact that the applicant was appointed in the post of Sub-Inspector in the Department of Food & Supplies on the basis of order dated April 11, 2017 issued by the respondent no. 2, we are of the view that the applicant should be permitted to join in the post.

In view of our above findings, we direct the respondent no. 2, Director of DDP&S, Department of Food & Supplies to join in the post of Sub-Inspector on the basis of order dated April 11, 2017 within **3 (three) days from this date**. The applicant is not entitled to get any financial benefit before the date of joining. The seniority of the applicant in the service will be decided on the basis of seniority rules by which the applicant is governed.

With the above direction, the original application is **disposed of**.
