record to indicate that the applicant was engaged as full time casual/daily rated/contractual employee in the establishment of the respondent no. 3 for more than ten years with the approval of the Departmental Secretary of the Government of West Bengal and as such the applicant is not entitled to get remuneration in terms of Memorandum No. 9008-F(P) dated September 16, 2011 and other subsequent Memorandums issued in this regard from time to time by the Finance Department, Audit Branch, Government of West Bengal.

We have heard Learned Counsel for the applicant. None appears on behalf of the state respondents in spite of service of notice as reflected from the Affidavit of service filed on behalf of the applicant. The fact of payment of monthly remuneration @ Rs.,2,000/- per month to the applicant as Water Carrier indicates that the applicant is a part-time casual employee who is entitled to get remuneration @ Rs.2,000/- per month in terms of Memorandum No. 3727-F dated May 20, 2009 issued by the Finance Department, Audit Branch, Government of West Bengal. However, the applicant is entitled to get enhanced remuneration @ Rs.3,000/- per month as Water Carrier w.e.f. January 1, 2018 in terms of Memorandum No. 7284-F(P2) FA/O/2M-1 dated November 27, 2017 issued by the Finance (Audit) Department, Government of West Bengal.
