	The applicant has prayed for direction upon the	
	respondents to grant family pension in favour of the	
	applicant who happens to be the unmarried daughter of	
	the deceased Government employee.	
	One Kshirod Mohan Dutta Gupta was an	
	employee of the Department of Animal Husbandry,	
	Government of West Bengal. He retired from service in	
	the year 1985 and got pension, but he died in the year	
	1988. The wife of Kshirod Mohan Dutta Gupta pre-	
	deceased him. Kshirod Mohan Dutta Gupta died	
	leaving behind four daughters and one son as legal	
	heirs. The applicant happens to be the unmarried	
	daughter of the deceased Government employee. On	
	June 4, 2010, the applicant submitted one application	
	for grant of family pension before the respondent no. 3.	
	The said application was duly processed and forwarded	
	to the respondent no. 6. On June 15, 2011, the formal	
	application for drawal of family pension was forwarded	
	to the respondent no. 6 by the respondent no. 3. On	
	January 11, 2013, the Accounts Officer of the

respondent no. 6 communicated to the respondent no. 3 that the case of the applicant for grant of family pension can be finalised only after obtaining approval from the Finance Department, Government of West Bengal as per Memorandum No. 830-F (Pen) dated September 20, 2010 issued by the Special Secretary to the Government of West Bengal, Finance Department (Pension Branch). The applicant is totally in the dark about obtaining approval from the Finance Department by the parent department of the deceased employee.

Under such circumstances, we direct the respondent no. 1, Principal Secretary, Department of Animal Husbandry, Government of West Bengal to forward the case of the applicant for grant of family pension to the Finance Department, Government of West Bengal for obtaining approval for grant of family pension to the applicant in terms of G.O. No. 830-F (Pen) dated September 20, 2010 issued by the Special Secretary to the Government of West Bengal, Finance Department (Pension Branch) within a period of 12 (twelve) weeks from the date of communication of the order.

With the above direction, the original application stands **disposed of.**
