	The applicant got promotion to the post of Head	
	Warder in Alipore Central Correctional Home by order	
	dated February 5, 2015 issued by the respondent no. 3.	
	The respondent no. 2 issued Circular dated April 24,	
	2018 inviting applications to fill up the vacancies in the	
	rank of Assistant Controller of Correctional Services by

interview for the selection to the post of Assistant Controller of Correctional Services is scheduled to be held on June 15, 2018 which may also be deferred to any other date.

On consideration of provisions of Section 5 of the West Bengal Correctional Services Act, 1992, we find that the post of Sub Jailor under the Prison Act, 1894 is equivalent to Assistant Controller of Correctional Services under the provisions of West Correctional Services Act, 1992. The provisions of Section 5(4) of the West Bengal Correctional Services Act, 1992 further provides that the qualifications and method of recruitment to the Officer and Staff of the Correctional Homes shall be such as prescribed. No Rule in this regard is placed before us at the time of hearing. Naturally, by following the provision of APPENDIX 34 of West Bengal Jail Code Volume II, we find that there is no age limit for promotion to Sub Jailor which is redesignated as the post of Assistant Controller of Correctional Services. Accordingly, the applicant should not be debarred from participating in the selection process for promotion to the post of Assistant Controller of Correctional Services due to age bar. As a result, the respondent no. 2 is directed by an interim order to grant permission to the applicant to participate in the selection process on the basis of the application already submitted by the applicant irrespective of his age, but the publication of the result of the selection process will be subject to the
