	The applicants have prayed for direction upon the	
	respondents for refixation of pay by giving pay protection in	
	terms of Rule 55(4) of West Bengal Service Rules, Part-I on the	
	ground that the juniors to the applicants in service are getting	
	higher scale of pay.	
	The applicant no. 1, Dilip Chandra Majumder joined in the	
	service as Fireman on September 22, 1967 and he retired on	
	December 31, 2006. The applicant no. 2, Sanatan Chakraborty	
	joined in the service as Fireman on September 15, 1965 and he	
	retired from service on April 30, 2005. The deceased husband	
	of the applicant no. 3, Late Prasanta Kumar Das joined in the	
	service on September 27, 1965 as Fireman and he must have	
	retired either in 2005 or in 2006, but the date of retirement is not	
	disclosed in the application. The husband of the applicant no. 3	
	and others moved the Tribunal by filing OA-4310 of 2008 praying	
	for refixation of pay by giving pay protection on the ground that

the juniors of those employees in service were getting higher scale of pay. On June 17, 2008, the Tribunal disposed of OA-4310 of 2008 by directing the Director General, West Bengal Fire and Emergency Services to consider the original application by treating the same as representation and dispose of the same by passing a reasoned order within specified period of time. It appears from the materials on record that on January 14, 2009, the Director General, West Bengal Fire and Emergency Services passed one reasoned order by making observation that there is pay disparity in case of applicant nos. 1 and 2 and the husband of the applicant no. 3 and others and as such the matter was referred to Department of Fire and Emergency Services, Government of West Bengal for decision. The contention of the present applicants is that they are not aware of any decision taken by state respondents. The applicants were silent without taking any action for almost 7 years. On June 17, 2016, the applicants submitted one representation before the respondent no. 1 praying for financial benefits due to pay anomaly. Without pursuing the remedy immediately after passing of the reasoned order by Director General, West Bengal Fire and Emergency Services, the applicants have approached the Tribunal almost after 8 years by filing the present original application on January 10, 2017 and after almost 12 to 13 years of retirement of the applicant nos. 1 and 2 and deceased husband of the applicant no. 3.
