entitled to get family pension as per provisions of Rules 104 and 105 of the West Bengal Services (Death-cum-Retirement Benefits) Rules, 1971 (hereinafter referred to as DCRB Rules, 1971).

The minor son of the applicant Arnab Dey is entitled to get family pension w.e.f. January 18, 2012. Since Arnab Dey is minor, the amount of family pension to which Arnab Dey is entitled will be disbursed in favour of the natural guardian of Arnab Dey. The applicant being the father of Arnab Dey is the natural guardian under the provisions of Hindu Law. The minor son Arnab Dey is entitled to get family pension from January 18, 2012 till the date of attaining 25 years of age as laid down in Memorandum No. 1097-F (Pen) dated June 18, 1991 issued by the Joint Secretary to the Government of West Bengal, Finance Department, Audit Branch, by which Rule 104 of DCRB Rules, 1971 has been modified. It is relevant to point out that minor son Arnab Dey will get family pension directly from the authority concerned on attaining majority on June 1, 2018.
