Submission is since classes have begun in the month of May, 2018, direction may be issued permitting the applicants to join classes. If interim order is not granted, the applicant will lose attendance as well as one academic year which cannot be compensated in any manner whatsoever.

Opposing the prayer for interim order, Mr. Banerjee submits that since there is no sponsorship and as Trainee Reserve quota has not been declared, no interim order may be passed.

So far as the prayer for the grant of interim order is concerned, since classes have commenced from the month of May, 2018 and if the applicants do not attend classes, they run the risk of losing attendance as well as one academic year, the applicants are at liberty to attend the classes without prejudice to the rights and contentions of the parties. Any action taken shall abide by the result of the original application.
