subscription of GPF of the applicant during the period from June 1997 to November 1997, September 1998 to March 1999 and April 2004 to May 2007 along with T.V. No. and date and submission of claim application of the applicant in Form 10A for disbursement of the final amount of GPF in favour of the applicant. Mr. Mitra has also placed on record the documents to establish that a sum of Rs.1,47,493/-was already sanctioned towards the amount of GPF of the applicant. Learned Counsel representing the applicant submits that the said amount of Rsl.1,47,493/- has already been received by the applicant, but the balance amount of GPF has not yet been received for not furnishing the particulars by the respondent no. 4 before the respondent AG (A&E), West Bengal. Let the documents produced by Mr. Mitra be kept on record.

On consideration of the materials on record, we find that the respondent AG (A&E), West Bengal could not finalise the amount of GPF to be paid to the applicant for not furnishing the information about missing credit of subscription of the applicant by the respondent no. 4. However, no explanation is forthcoming as to why the respondent no. 4 did not make payment of the amount of Group Insurance to the applicant who retired on January 31, 2010.

Under the above circumstances, we direct the respondent no. 4, Block Development Officer, Chakdaha Block, Nadia to furnish the information required by the Accounts Officer of AG (A&E), West Bengal under letter dated February 10, 2017 and
