supplementary application till date. We are unable to ascertain from the materials on record whether the amount of GPF, Group Insurance and Leave Encashment, if any, have already been released in favour of the applicant.

Having heard Learned Counsel for the applicant, Learned Counsel for the state respondents and the Departmental Representative of the respondent AG, West Bengal, we are of the view that the applicant is entitled to get the amount of GPF, the amount of Group Insurance and the amount of Leave Encashment admissible to the applicant, if the said amount has not been released in the meantime. We are informed that the applicant has not submitted the applications in prescribed format for release of GPF etc.

Under the above circumstances, we direct the applicant to submit application in the prescribed format for release of the amount of GPF if the applicant has not received the amount of GPF in the meantime, within a period of 4 (four) weeks from this date before the Pension Sanctioning Authority viz., the respondent no. 3, Senior Joint Commissioner, Commercial Taxes (Administration), Central Section, Kolkata – 700 014. The respondent no. 3 is directed to release the amount of GPF, Group Insurance and Leave Encashment admissible to the applicant, within a period of 12 (twelve) weeks from the date of submission of the applications in the prescribed format, if the
