representations and submission of all necessary documents before the respondent No. 4, Principal, National Medical College and Hospital, Kolkata. The copy of letter addressed to the respondent No. 2 by the respondent No. 4 (page 28 and page 29 of the original application) indicates that the respondent No. 4 has already recommended for payment of arrears of salary of the husband of the applicant after obtaining necessary sanction from the higher authority.

With the above factual matrix, Learned Counsel for the applicant contends that arrears of salary of the husband of the applicant have not yet been paid. Mr. Basu, Learned Counsel representing the State respondents submits that the process has already been initiated by the State respondents for payment of arrears of salary and the same will be disbursed within very short period of time.

Under the above circumstances, we direct the respondent No. 2, Director of Medical Education and Ex-Officio Secretary to the Government of West Bengal, Department of Health and Family Welfare to take all necessary steps for disbursement of arrears of salary of the husband of the applicant during the period from January 1, 1988 to November 30, 2001 after obtaining necessary approval from the higher authority, if required, on consideration of letter addressed to the respondent No. 2 by the respondent No. 4 in this regard (page 28 and page 29 of the original application) within a period of 16 weeks from
