	The applicants have prayed for direction upon the	
	respondents for granting them promotion to the post of	
	Assistant Engineer (Civil) in the Directorate of Public	
	Health Engineering, Government of West Bengal on	
	consideration of the representations submitted by each	
	of them on April 2, 2019.	
	It appears from the materials on record that the	
	applicants joined in the post of Sub-Assistant	
	Engineers in the Directorate of Public Health	
	Engineering during the period from 1979 to 1982 and	
	retired from service on different dates during the period	
	from 2014 to 2018. The grievance of the applicants is	
	that they have been deprived of promotion to the post of	
	Assistant Engineers in spite of fulfilling eligibility	
	criteria for promotion, though some Sub-Assistant	
	Engineers were granted adhoc promotion to the post of	
	Assistant Engineers and subsequently the said adhoc	
	promotion was regularised by giving benefits of service	
	to all of them.	
	Mr. M.N. Roy, Learned Counsel for the	
	applicants, has not pressed for prayers of the original

have prayed for direction upon the respondents to consider and dispose of the representations submitted by them.

Mr. G.P. Banerjee, Learned Counsel representing the state respondents, submits that he has no objection in consideration of the representations submitted by the applicants, but the Tribunal must keep in mind that all of them have approached the Tribunal after their retirement from service.

Having heard Learned Counsel representing both parties and on consideration of the submission made from the Bar, we are of the view that the respondent no. 1 should consider the representations of the applicants in accordance with law within a specific period of time. Accordingly, the respondent no. 1, Principal Secretary to the Government of West Bengal, Department of Public Health Engineering is directed to consider the representations submitted by each of the applicants on April 2, 2019 (as reflected from the supplementary application filed by the applicants) in accordance with law within a period of 12 (twelve) weeks from the date of communication of the order and convey the decision to the applicants within a period of 2 (two) weeks thereafter.

With the above direction, the original application stands **disposed of.**
