The reply filed on behalf of respondent No. 5 indicates that the certificate of Scheduled Tribe produced by the applicant was found to be fake during police verification. The record of police verification is not placed before the Bench and as such, we are not in a position to decide whether the Scheduled Tribe Certificate produced by the applicant was genuine or fake. Since Sub-Divisional Officer, Diamond Harbour, South 24 Parganas seems to have issued Scheduled Tribe Certificate No. DS / 500004 dated October 27, 1995 on
