	The applicant has prayed for direction upon the	
	respondent no. 2 for release of salary of the applicant during the	
	period of suspension and to issue order of promotion to the post	
	of ASI (UB) and benefit of Career Advancement Scheme.	
	It appears from the materials on record that the

	was working as Constable of Police in the establishment of the

	The charge levelled against the applicant was dropped and the	
	period of suspension of the applicant from September 12, 2015	
	to December 2, 2015 was not confirmed and direction was given

has not been considered for promotion after cancellation of his suspension and that the applicant was not given any benefit of Career Advancement Scheme in spite of dropping of the charge levelled against him.

Having heard Learned Counsel representing both parties and on consideration of the fact that the charge levelled against the applicant has already been dropped with observation of giving backwages to the applicant for the period of suspension, we direct the respondent no. 2, Superintendent of Police, Dakshin Dinajpur to consider entitlement of the applicant to get financial benefits including salary for the period of suspension and service benefits including promotion to the post of ASI (UB) and benefit of Career Advancement Scheme in accordance with law within a period of 12 (twelve) weeks from the date of communication of the order and to take necessary follow up action within a period of 4 (four) weeks thereafter.

With the above direction, the original application is **disposed of.**
