less educational qualification.

Having heard Learned Counsel representing both parties, we find that the essential qualification for recruitment to the post of Technical Assistant is Bachelors Degree with Anthropology as one of the subject, whereas the essential qualification for recruitment to the post of Caretaker is intermediate/preuniversity/higher secondary examination and experience of collection, preservation and display of museum specimen. Since the essential qualification for recruitment to fill up the post of Caretaker is different from essential qualification for recruitment to fill up the post of Technical Assistant, the state respondents have the right to prescribe different pay scales for the said two posts which belongs to different cadres under the Department of Backward Classes Welfare, Government of West Bengal. Since the two posts belong to different cadres, we are unable to accept the contention made on behalf of the applicant that the applicant has been discriminated.

On our query, Learned Counsel for the applicant submits that the advertisement for filling up the post of Caretaker has not yet been published. If the advertisement for recruitment is published in future, the applicant is at liberty to apply for the post of Caretaker subject to fulfilment of essential qualifications prescribed for recruitment to fill up the said post.
