10 (ten) applicants who have been impleaded as applicant nos. 7 to 16 in OA-917 of 2015 by way of amendment on this date, have not filed copy of letters by which each of them was communicated the reasons for not giving appointment. Liberty is given to the applicant nos. 7 to 16 of OA-917 of 2015 to file supplementary application by annexing copy of letters by which each of them was communicated the reasons for not giving appointment within a period of 2 (two) weeks from this date.

It appears from Affidavit submitted by respondent no. 2 that enquiry is pending before State Vigilance Commission against all 38 (thirty eight) applicants of 6 (six) different original applications (OA-872/2015, OA-912/2015, OA-913/2015, OA-916/2015, OA-917/2015 and OA-1092/2015). The documents kept on record reveal that the matter was referred to State Vigilance Commission by the Department of Irrigation & Waterways, Government of West Bengal on March 18, 2014, but no response has yet been received by the Department of Irrigation & Waterways, Government of West Bengal and thereby the said department is not in a position to take any decision in connection with the appointment of 38 (thirty eight) applicants who have approached this Tribunal in the year 2015.

Having heard Learned Counsel representing both parties, liberty is given to the applicant to implead State
