	The applicants have prayed for direction upon the	
	respondents to grant them scale no. 19 along with the status of	
	Joint Secretary on relaxation of rules in respect of shortfall in the	
	length of service in the light of the judgment passed by this	
	Tribunal in OA-177 of 2013 being affirmed by the Hon'ble High	
	Court in WPST No. 227 of 2014.	
	It appears from the materials on record that seven	
	applicants belong to West Bengal Civil Service (Executive). The	
	contention of the applicants is that they are promotee officers of	
	1992 batch and placed in the gradation list above the directly	
	recruited officers of the same batch of 1992. The grievance of the	
	applicants is that they have not received scale no. 19 from the date	
	they would have been eligible to enjoy benefit of scale no. 19 and	
	status of Joint Secretary to the Government of West Bengal due to	
	joining in the service in 1997. The further contention of the	
	applicant is that they could not join along with the directly recruited	
	officers of the same batch of 1992 who joined in the year 1993 due	
	to administrative lapses over which the applicants had no control.	
	The applicants have been deprived of the financial benefits and

status due to administrative lapses on the part of the state respondents. The state respondents have not given any reply denying the allegations made by the applicants in the original application.

Having heard Learned Counsel representing both parties and on consideration of the materials on record, we find that the applicants are similarly situated with the applicants of OA-177 of 2013 (Sukumar Das and Others v State of West Bengal and Others) which was disposed of in favour of the applicants on February 7, 2014. The judgment passed by the Tribunal in OA-177 of 2013 was also affirmed by the Division Bench of the Hon'ble High Court on May 5, 2015 in WPST no. 227 of 2014. Since the applicants are squarely covered by the previous judgment of the Tribunal in OA-177 of 2013 which was affirmed by the Hon'ble High Court in WPST no. 227 of 2014, we are of the view that the respondent no. 2 should take into consideration the said judgments passed by the Tribunal and the Hon'ble High Court in giving financial benefits to the applicants on the basis of principle already laid down by this Tribunal and affirmed by the Hon'ble High Court.

Accordingly, we direct the respondent no. 2, Principal Secretary to the Government of West Bengal, Personnel and Administrative Department to consider the entitlement of the applicants to get scale no. 19 along with status of Joint Secretary to the Government of West Bengal on relaxation of rules in respect of shortfall in the length of service of the applicants on
