	issued on 24.05.2011 (Annexure-B). On the basis of the	
	circular, applications were invited from the willing	
	Health Assistants (Female) as well as Grade-III A.N.M	
	(Old) candidates for Promotees Training Courses of	
	Health Supervisor (Female).	
	However, as per the records, she has made an	
	application before the Joint Director of Health Services	
	(Nursing), West Bengal, Sasthya Bhavan, Salt Lake,	
	Sector-V, Kolkata-91 on 04.08.2015 praying for	
	promotion and posting as Health Supervisor (Female)	
	at Nandigram B.P.H.C. Nandigram, District- Purba
