The matter is taken up by the single Bench pursuant to the Notification Nos. 949-WBAT/2J-15/2016 dated 24<sup>th</sup> December, 2020, 456-WBAT/2J-15/2016 dated 16<sup>th</sup> July, 2021 and 586-WBAT/2J-15/2016 dated 31<sup>st</sup> August, 2021 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunal Act, 1985.

It is submitted by Mr. M.N. Roy, learned advocate for the alleged contemnor opposite party that Pradip Roy is the present incumbent, that is the Deputy Secretary, Public Health Engineering Department, Government of West Bengal. The learned advocate on record for the applicant is directed to incorporate the name of Pradip Roy by amending the cause title of the contempt application in course of this day.

Let a copy of the letter dated 2<sup>nd</sup> September, 2021 by A.K. Nag, learned advocate to Mr. M.N. Ray, learned advocate on record for the alleged contemnor opposite party be kept on record. It is submitted by Mr. Roy that an application being W.P.S.T. 66 of 2021 has been filed challenging the orders dated 20<sup>th</sup> January, 2020, 26<sup>th</sup> August, 2020 and 18<sup>th</sup> November, 2020 passed by the Tribunal in MA. 13 of 2020 arising out of OA 224 of 2019 (Sukanta Paul & Another vs-State of West Bengal & Others) .

Mr. A. Ray Mukherjee, learned advocate for the applicants supporting the contempt application submits that an interim order may
