In the case of compliance of the aforesaid direction under clause (i) above, the contemnor / opposite party is directed to be present either through the learned advocate, and or, in person on the next date.

Accordingly, the next date is fixed on 7th April, 2022 for compliance of the above directions, and appearance of the contemnor / opposite party as directed above.
