Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 03.12.2021 in original application bearing O.A. No 565 of 2015, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.

Perused the application along with all annexure hereinafter referred to as the "**said application**".

Considering the nature of substantive relief as prayed for, the said application is required to be served upon the alleged contemnor / opposite party herein to enable him to show cause as to why the appropriate order / mandatory direction should not be issued by this Hon'ble Tribunal for alleged non-compliance and violation as stated in the said application, and to ensure compliance of the said order in question.
