Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 24<sup>th</sup> November, 2021 in original application O.A. 382 of 2020: Ajoy Sarkar vs. The State of West Bengal and Others, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.
