Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 29th July, 2021 in original application O.A. 456 of 2020: Madhabi Das vs. The State of West Bengal and Others, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.

In the case of compliance of the aforesaid direction under clause (i) above, the contemnor / opposite party is directed to be present either through the learned advocate, and or, in person on the next date.

Accordingly, the next date is fixed on **2nd September, 2022** for compliance of the above directions, and appearance of the contemnor / opposite party as directed above.
