The instant application has been filed being aggrieved with the non-compliance of the order dated 11.03.2020 whereby the following direction was given :

*"In view of our above findings, we direct the respondent No. 2, Director of Personnel and Ex-Officio Chief Engineer, Directorate of Irrigation and Waterways to consider whether the applicant is similarly circumstanced with the applicants of Jhunu Majumder & Others v State of West Bengal & Others (OA-1193/2013, OA 1194/2013 & OA 1195/2013) by passing a reasoned order within a period of twelve weeks from the date of communication of the order. If the respondent No. 2 comes to the conclusion that the applicant is entitled to get pay protection at par with the private respondent No. 5, he will take necessary steps for refixation of pay of the applicant and consider the issue of refund, if any, in favour of the applicant within a period eight weeks from the date of passing the reasoned order.*

*With the above direction, the original application stands disposed of."*
