The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

This contempt application has been filed alleging non-compliance of the directions contained in the order dated 8th February, 2021 in OA-5 of 2021 (Monojit Bagish Vs. The State of West Bengal and Others). It is submitted by Mr.G.P.Banerjee, learned advocate for the alleged contemnor on instruction that pursuant to the directions contained in the said order, the alleged contemnor had considered that case of promoting the applicant on provisional basis during the pendency of the departmental proceedings and had rejected his prayer by orders dated 28th June, 2021, 20th July, 2021 and 24th November, 2021.

Mr.M.N.Roy, learned advocate appearing on behalf of the applicant submits that the directions contained in the order dated 8th February, 2021 have not been complied with as it has been rejected on flimsy grounds. However, it is submitted that the applicant has challenged the orders of rejection by filing an application being OA-883 of 2021 which is pending.
