The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under Section 6(5) of the Administrative Tribunals Act, 1985.

The instant application has been filed being aggrieved with the non-implementation of order dated 03.03.2022, whereby following directions were given :

**“In view of the above, the respondents are directed to provide family pension to the applicant. The counsel for the applicant has submitted that at present she is only asking for family pension and with regard to the other claim, the decision may be taken as per Rules. In view of the above, the respondents may take decision as per Rules.**

**Accordingly, the O.A. is disposed of with no order as to cost.”**

During the course of the hearing, the counsel for the applicant has submitted that though PPO has been issued in favour of the wife of the deceased employee with regard to family pension, however, with regard to other retiral benefits, neither they have been paid anything nor any order has been communicated to them in this regard.

However, the counsel for the contemnor opposite party has submitted that they have complied with the order and has submitted that one order dated 09.06.2022 and 14.07.2022. Let the copy of both the orders be kept with the record.

I have gone through the Memo. dated 09.06.2022 issued by the Superintendent of Police and from the perusal of the said Memo, it is noted that this Memo is only with regard to disbursement of family pension and communication dated 14.07.2022 is with regard to the directions by the Assistant Accounts Officer of AG, WB to the Treasury Officer, Barrackpore
