The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Mr. Ghosh, learned counsel has presented a copy of memo. no. 92-F(Pen) dated 13.03.2025. On the other hand, Mr. Mitra, Learned Departmental Representative has presented a copy of memo. no. 479730 dated 22.08.2025.

From a closed reading of these two documents, the Tribunal finds that the matter relating to sanction of family pension to the applicant is being actively processed. Mr. Mitra has added by stating that once the Sub-Divisional Officer, Kalyani, Nadia responds to his memo. dated 22.08.2025 and if everything is found to be correct, the office of the Principal Accountant General (A&E), West Bengal will issue the Pension Payment Order.

Mrs. Das, learned counsel having heard the observations of the Tribunal submits that the applicant, being a Cancer patient is in need of financial support and only an expeditious action by the respondent authorities will help her.

Having heard the condition of the applicant from Mrs. Das, this Tribunal directs the alleged respondent no. 5, the Sub-Divisional Officer, Kalyani, Nadia to respond to the letter dated 22.08.2025 of Principal Accountant General (A&E), West Bengal within fifteen (15) days from the date of communication of this order. Once the response from the respondent no. 5, the Sub-Divisional Officer, Kalyani, Nadia is received, the respondent no. 2, the Principal Accountant General (A&E), West Bengal shall process the proposal and if found entitled, the PPO be issued within thirty (30) days from the date of response of
