The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Affidavit of service filed be kept on record.

This contempt application has been filed alleging non-compliance of the order of this Tribunal passed on 11.12.2023 in OA 557 of 2023. By this order, the Tribunal had directed the S.D.L. & L.R.O., Contai to examine the proposal for family pension of the applicant and after processing the same, it be sent to the higher authorities. In the original application, Subhashri Jana, the applicant had prayed for a direction to the respondent authorities to sanction her family pension as the divorced daughter of Asit Baran Jana, the deceased employee. In terms of such direction, as submitted by the Departmental Representatives with the support of documents, the S.D.L. & L.R.O., Contai submitted such a proposal before the Department. The Department having obtained the approval of the Finance Department for such proposal returned the matter to the A.D.M. and D.L. & L.R.O, Purba Medinipur. The Finance Department had approved the proposal with the remark that such family pension be sanctioned if the authority is satisfied about the genuineness of the claimant. The Deputy Director and S.D.L. & L.R.O. in terms of a direction has asked the applicant to furnish the following five documents.

- 1) Up-to-date Income Certificate issued by B.D.O.
- 2) Finance details as on 30.09.2024.
- 3) Holding family details.
- 4) Certificate of present marital status.
- 5) Affidavit (1st Class Magistrate) regarding the genuineness of her claim.

It is understood that after examination of these documents and after being satisfied of the genuineness of the claim, the Pension Sanctioning
