In the case of compliance of the aforesaid direction under clause (i) above, the contemnor / opposite party is directed to be present either through the learned advocate, and or, in person on the next date.

Accordingly, the next date is fixed on **25<sup>th</sup> April, 2022** for compliance of the above directions, and appearance of the contemnor / opposite party as directed above.
