Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 13.08.2021 in original application bearing O.A. No 488 of 2021, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.

Perused the application along with all annexure hereinafter referred to as the "**said application**".

Considering the nature of substantive relief as prayed for, the said application is required to be served upon the alleged contemnor / opposite party herein to enable him to show cause as to why the appropriate order / mandatory direction should not be issued by this Hon'ble Tribunal for alleged non-compliance and violation as stated in the said application, and to ensure compliance of the said order in question.

In view of the above, the applicant is directed to comply the following directions as follows :-

- i) the **said application** along with the **present order** passed today be served upon the contemnor / opposite party by speed post with proof of delivery, and or, by registered post with acknowledge due card, and or, by hand at once with a forwarding letter indicating the **next date** of the case stated hereinbelow, and
- ii) an affidavit of service annexing the copy of the aforesaid

forwarding letter, original postal receipts, delivery status down loaded from the official website of the India post (<https://indiapost.gov.in>), in case of service through post, whereas in the event of direct service, the original receipted copy or copies of the forwarding letter/ letters bearing seal and signature of the receiving staff of the contemnor / opposite party, shall be produced on the next date.

In the case of compliance of the aforesaid direction under clause (i) above, the contemnor / opposite party is directed to be present either through the learned advocate, and or, in person on the next date.

The office is directed to upload the order passed today on the official website of the Tribunal (<https://wbato.gov.in>).

Accordingly, the next date is fixed on **03.08.2022** for compliance of the above directions, and appearance of the contemnor / opposite party as directed above.
