The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

By presenting copies of Memo. No. 1073 dated 03.05.2024, Mr.Ghosh, learned counsel submits that the direction of this Tribunal has been complied. By an order dated 13.06.2022 in OA-1020 of 2018 this Tribunal had directed the Agriculture Department and the Finance Department to issue necessary approval to the proposal of promotion of the applicant. By the Memo. referred above being No. 1073, it is clear that with approval of the Finance Department, the retrospective promotion to Shri Dinesh Chandra Mondal from 26.12.2007 has been given. Additionally, a payment of arrear @ 6 % interest has also been granted. Mr.Karan, learned counsel, however, is not satisfied and submits that despite compliance by the Department of Agriculture and Finance, the Assistant Director of Agriculture, (Admn) Basirhat Sub-Division has not yet completed the calculation and the benefits have not been given to the applicant.
