The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

At the outset, Mr. Mitra, learned Departmental Representative on behalf the Principal Accountant General (A&E), West Bengal submits that the name of alleged Contemnor/OP No. 4, Smt. Debolina Thakur may be replaced with the new incumbent, Mr. Atul Prakash. Let the name of Mr. Atul Prakash be recorded in place of Smt. Debolina Thakur.

Relating to the compliance of the order of the Tribunal dated 21.04.2022, Mr. Ghosh, learned counsel appearing on behalf of the alleged Contemnor/OP submits that the dates of his temporary service period has already been corrected and now the matter has been referred to Pay & Accounts Office. Once it is approved by them, the proposal will be submitted to the office of the Principal Accountant General (A&E), West Bengal. Mr. Mitra by filing a copy of memo dated 21.09.2023 informs that the alleged Contemnor/OP, Shri Santanu Basu has been advised to take appropriate steps to comply with the direction of the Tribunal regarding pension case of Shri Sadhan Chandra Deb, the applicant. For full compliance of the Tribunal's direction, Mr. Ghosh prays for some time. Mr. Ghosh will also submit copies of references made by the respondents to the Pay & Accounts Office on the next date of hearing.

The matter is admitted.
