The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536-WBAT/2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The instant application has been filed being aggrieved with the non-implementation of the order dated 12.08.2021, whereby the respondent No. 6 i.e. the Assistant Farm Manager, Dubrajpur Block Seed Farm, Birbhum was directed to consider the representation of the applicant dated 05.03.2021 and to take final decision and communicate the same within a period of six weeks. Subsequently, the counsel for the contemnor has placed one reasoned order dated 15.02.2021.

I have heard the parties and perused the records. It is noted that the contemnor, in his reasoned order dated 15.02.2021, has observed inter alia:

"The claim payment for the period from June, 2017 to September, 2017 is still due and their claim demand is not readily available in this end but they were requested to submit the fresh demand for the stated period but they have failed to submit the fresh demand till date.

In the above circumstances, the Drawing & Disbursing Officer will arrange to draw the pending claim amount for the period from June, 2017 to September, 2017, if they submit the bill afresh."

As per the applicant, as the applicant has to be paid his due salaries from June, 2017 to September, 2017, the question of raising bill or payment does not arise as the payment or any bill has to be raised by the authority and make payment thereof.

It is further noted that the applicant has basically came before this Tribunal praying for a direction to the respondent to release the due salaries of

the applicant for the month of June 2017 to September, 2017 as well as for the month of March and April 2020. Though as per the applicant, he has been paid the salaries for the month of March and April 2020, however, he has not been paid the salaries from the month of June 2017 to September 2017.

In view of the above, I am not satisfied with the reasoned order dated 15.02.2022, therefore, the contemnor is granted one last chance to comply with the order and file compliance report by the next date, in default, the contemnor is directed to be present before this Court on the next date.

The Registry is directed to send this order to the contemnor.
