Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 8<sup>th</sup> October, 2020 in original application bearing O.A. No 105 of 2020, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.

ii) an affidavit of service annexing the copy of the aforesaid forwarding letter, original postal receipts, delivery status down loaded from the official website of the India post (<https://indiapost.gov.in>), in case of service through post, whereas in the event of direct service, the original receipted copy or copies of the forwarding letter/ letters bearing seal and signature of the receiving staff of the contemnor / opposite party, shall be produced on the next date.

In the case of compliance of the aforesaid direction under clause (i) above, the contemnor / opposite party is directed to be present either through the learned advocate, and or, in person on the next date.

In addition to the above, the said application be also served upon Mr. B. Mitra, Departmental Representative for the Principal Accountant General (A&E), Government of West Bengal.

Accordingly, the next date is fixed on **28<sup>th</sup> April, 2022** for compliance of the above directions, and appearance of the contemnor / opposite party as directed above.
