Being aggrieved by the non-compliance of the order passed by this Hon'ble Tribunal on 02.12.2020 in MA-64 of 2020 arising out of original application bearing O.A. No 839 of 2019, the present application in terms of section 27 of the Administrative Tribunals Act, 1985 has been filed to secure execution of the aforesaid order.

Perused the application along with all annexure hereinafter referred to as the "**said application**".
