Since it is submitted that Smt. Manirupa Bhattacharya, the Additional Secretary to the Government of West Bengal, Panchayat and Rural Development Department (R D Wing), Kolkata, is the present incumbent, let her name be added by amending the cause title of the contempt application as an alleged contemnor by the learned advocate for the applicant in course of this day. It is submitted by Mr.S.Ghosh, learned advocate for the alleged contemnor that the matter is pending since 2018 before the Finance Department, Government of West Bengal for approval.

We fail to understand why the direction contained in the order dated 7th November, 2017 passed in OA-164 of 2015 has not been complied with till date as no decision has been taken by the alleged contemnor. Therefore, let the matter appear under the heading "For Order" on 1st December, 2021 when Smt. Manirupa Bhattacharya, the alleged contemnor shall be present in the Tribunal along with records to explain her stand when the matter is taken up for hearing and shall not leave the Tribunal without the leave of the Tribunal.
